The OLL ended fiscal year 2023 in sound financial condition. With grants from the OLL Foundation, the OLL posted a profit of \$92,318 MXN. The OLL projects a profit of \$43,869 without the use of grants.

The last business for the 2024 AGAM was to know that because Gail was elected president, the position of Vice President would need to be appointed by the BOD at the April meeting. Any member who is interested in appointing someone to the position should submit that information to Mary Phillips, Secretary, and she will get that information to the BOD before the April meeting.

There was no new or old business to discuss.
