### **Treasurer's Report**

Book purchases in the US

Doug Harmon set up a way to buy books in the States through the OLLF. Buying books occasionally through the OLLF is not a problem. However, when the OLL buys significant quantities of books through the OLLF, the amount of the purchases is considered as a grant from the OLLF, and income for the OLL. We pay 30%+ tax now on our income. When we are a donataria, this will not be an issue. Right now, we can set up a US dollar account at Bancomer. We can use this account to buy books with dollars from the OLLF. There is no tax issue because we have expenses (the books) to offset the grant from the OLLF. Therefore, OLL will not have income to tax. When the OLLF buys books, the expenses are the OLLF's not the OLL's. OLL needs to further investigate the requirements for a dollar account at Bancomer~is there a minimum, and how much activity is required each month?

#### **Old Business**

#### Protocol for medical emergencies

Terry Banen has sent a recommended outline for a session and had questions about when and where the training could occur.

Doug Long suggested that we move forward with this idea. Marirose suggested moving ahead with a few people for training and then expanding the group. Gloria suggested that we start with volunteers that are already working at the OLL. Terry's outline was accepted.

This letter is a new requirement. Next step occasional purchases by book committee. From book committee get an estimate of the number and/or cost of purchases.

#### **New Business**

#### PROPOSED POLICY
