Membership Analysis

- Donataria status provided by Marirose disagrees with the status provided on March 18<sup>th</sup> which said that the application was with SAT in Mexico City whereas the status given today stated that it is with the Cultural Ministry and next goes to SAT. Ralph will confirm status with Marirose.
- QB user session with Marirose provided instruction on creating reports. Comfort with reporting from QB.
   Teresa is meeting with Marirose next week to go over the Treasurer's Report process and content before the Board meeting on Thursday. Teresa is unaware of where and how to get data from the OLLF.
- Discussion of the budget process led to highlighting the issue with running a deficit, especially observing that the first quarter income was apparently low and how that would affect the drawdown from the OLLF to keep OLL solvent. The committee asked that the treasurer insert the 3-month actual results into the remaining budget for the year so that the committee can begin an in-depth analysis of the factors that the OLL can impact for a positive financial result. Ralph and Teresa will meet on Saturday and create an income statement for the year with the 3-month actuals and the remaining 9-month budget forecast. Noted that any fund-raising initiated now would not have time to impact the 2025 financial results. Very serious!
- Memberships were thought to be a quick income punch. Ian believes that the 1-2-3-month memberships could possibly impact the number of memberships and income possible. <u>Ian</u> said that he would like to investigate, and <u>Ralph</u> volunteered to provide 6 years of monthly membership data to start an analysis.
- The questions accumulated by the committee to assist with a discussion with the OLLF were reviewed. Question one was revised to remove a reference to any specific fund and to lead to an understanding on how the OLLF records/accounts for donations that specify a specific use. The intent is to build on the relationships between the OLL and OLLF especially with new committee members who need to understand the financial relationship. The next step is to do a final question review and determine a date to meet with the OLLF.
